Dear Freshman Member of Congress:

Meet the high expectations of the people that elected you.

Seek out others that share your views and then join with them to become a block of votes and voices leadership cannot ignore.

If you will stay true to your cause, roots, and beliefs the task of living up to expectations will be easier. However, this is going to be a monumental undertaking, as much is expected of you in terms of turning this country back on course, and quickly.

As a freshman, you have no political clout built up over years of service. You will not be chairman of any influential committees. There will be those that the media will identify as "rising stars". The stars are still freshmen. Ignore them and continue with your task.

That is the political rhetoric comprising the backbone of the liberal left every time a suggestion to reel in the size of the bureaucracy is mentioned.

Follow up with intense scrutiny of the effected agency, point out how much more money would be available for program benefits and you will be able to achieve results beyond your wildest dreams.

Don't re-invent the wheel. Go back to 1995 and see what happened when the IRS budget was cut 10% and a \$1 billion per year waste of money was eliminated.

Lack of oversight on government agencies has been a huge contributor to excessive and wasteful spending. Oversight is your job. That's what we hired you to do.

We don't want you to be dreaming up new and wonderful programs we can't live without. We want you to get the bureaucracy's attention by taking away a portion of their funding and then doing an exhaustive audit and investigation into their operating practices.

Ask some of the old appropriators how to just "fence" off money for various programs and force the agencies to give you a precise plan on how the money will be spent and then do not release the money until your demands are met.

The Constitution declares that only the Congress has the power to spend money. Use that power wisely. If that is a difficult concept to understand, then try this one on for size.

As a taxpayer I am a stockholder in your bank (Congress). Your bank has the responsibility to protect my investment (i.e. taxes paid). Your bank is the only one that, by law, can disburse my "investment" to the various agencies that provide the services my investment demands (roads,

military, law enforcement, airports, FDA and etc.) Therefore, it is your responsibility to see that my investment is spent wisely and without undo waste, fraud and abuse.

Under this scenario, you should be tougher than any commercial bank in this country making a personal, business or home loan, as your “borrowers” are not going to pay you back. Additionally, you should not be passing money out to them based on a short, choreographed “hearing” as is now the practice.

Instead, each agency should be scrutinized at the highest degree possible. All aspects of the agencies operations should be put under the microscope and examined for best practices, efficiency, waste and existing as well as potentials for abuse. Then, and only then, should you extend them a check.

Just because an agency head is sitting across from you in a hearing room do not assume he/she is always telling the truth. As Ronald Reagan once said, “trust, but verify”.

In practical terms, to do this government wide in one stroke borders on the impossible. However, government agencies all suffer from the “Blackbird Syndrome”. That’s where several hundred Blackbirds are sitting on a telephone wire and then suddenly one of them takes off. No one knows where that one bird is headed but the entire flock takes off behind him.

Agencies work the same way. They watch each other like a Hawk (Blackbird).

Pick one or two agencies for the “Mr. Clean” treatment. Go after them in high profile. You will be surprised how many other agencies will start to clean up their acts.

The Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) would be a good place to start. It is one of the smaller agencies, therefore completing the audits and investigations will take less time. It is an agency that has drifted for nearly six years without a permanent Director.

ATF was recently featured on CNN regarding an agent who blew the whistle on an illegal wiretap and was rewarded with exile to an office with nothing to do for two years.

One of their Special Agents in Charge (SAC) was found by a local reporter to be driving a brand new Cadillac with all the bells and whistles plus a police package. His punishment was to move him to DC Headquarters with a promotion.

Check the millions of dollars paid out in settlements to employees as well as the huge backlog of employee complaints being ignored. Compare this to other larger agencies and you will be shocked at the level of abuse and waste.

Along with the smaller agency you should consider one of the “sacred cows”. Medicaid comes to mind as it is so filled with waste, duplication, fraud and inefficiency the savings alone will be in the billions if not trillions of dollars.

Bottom line, it is your responsibility and obligation to make these agencies accountable to you and, by extension through you, to me the taxpayer.

Demanding accountability is where you can make the biggest difference in the shortest amount of time.

It hasn't been done for years. Focus and cut, change Washington not the other way around.
